Looking back at 2015, we can record a continuous increase in numbers of both national and international memberships. Environmental Product Declarations according to EN 15804 have become a standard for the whole construction material industry. In the beginning of the year we successfully attended the fair BAU 2015 in Munich, where numerous EPDs were awarded and mutual recognition, for example with the



programme holder EPD Danmark, were agreed. Furthermore, we were very pleased to receive a positive feedback on our General Annual Meeting in June in Berlin. Conserving natural resources has become a big issue in the discussions about sustainability, especially in the construction industry. Therefore, the IBU Board decided to become a partner for the special award "Resource Efficiency" 2015. We would like to take the opportunity to remind you of one of our first events taking place in 2016. You can still register for the IBU Communication seminar that will be held on


28 January 2016 in Cologne. We would be pleased if you registered by 18 December 2016 via fax or email.
